Scottish Land Fund Grants Awarded

A community in the **Borders** is one of four today (FRI 22 FEB) taking control of their future, thanks to the new Scottish Land Fund, as the first grants are announced.

Launched last year, the £6 million Scottish Land Fund is funded by the Scottish Government and delivered by the Big Lottery Fund in partnership with Highlands and Islands Enterprise. Today's awards, of over £3/4 million, in the Borders, Cowal, Moray Firth and Wester Ross means these four communities can now purchase land and assets ensuring they are able to shape their own brighter future.

Scottish Land Fund Committee Chair, John Watt, said: "We know from experience that communities can achieve great things when they own and manage local land and land assets. So I am delighted to announce this first round of funding to these four projects and look forward to seeing them develop. Land ownership helps build independent, resilient and confident communities which benefits, not only themselves, but the country as a whole. The Scottish Land Fund, with funding over three years, aims to empower more rural communities, giving them the tools and resources they need so they can achieve their plans of local sustainability."

Richard Lochhead, Cabinet Secretary for Rural Affairs & Environment said, "I am delighted that the Scottish Land Fund is empowering four of our rural communities in Moray Firth, Cowal, Wester Ross and the Borders to take control of their own future by helping them to acquire land and community assets. These innovative and diverse projects will bring clear long term benefits, making each community stronger, resilient and more sustainable. I would urge other communities to look at these projects – three of which are achieved through the community right to buy provisions and the National Forest Land Scheme – to see how community land ownership and funding from the Scottish Land Fund can make a real difference to them."



Midlem in the Borders lies between St Boswells and Selkirk with the majority of its properties grouped around the village green. Today's grant of **£14,877** allows **Midlem Village Hall Committee** to purchase an area of land behind **Midlem Village Hall**. The hall is the focus of social and community events in the village and is well used. There are no level playing fields in the area and the plan is to use the additional land to create a patio area suitable for a wide variety of sports and activities which will generate additional income to improve the long-term sustainability of the hall.

Lawrence Robertson, Secretary, Midlem Village Hall Committee said: "Everybody at Scottish Land Fund has been very helpful at all stages and sensitive to the needs of small communities like Midlem. This is a great award for us. The hall is truly the heart of the village. Our wee community works really hard to provide lots of lively events throughout the year. Now that we have funds to acquire land next to the hall we are all excited at the prospect of enlarging the scope and of transforming a piece of unused rough grass into a great asset for Midlem."

Alex Paterson, Chief Executive of Highlands and Islands Enterprise (HIE), which is delivering the Scottish Land Fund in partnership with the Big Lottery Fund, said: "Highlands and Islands Enterprise is delighted to be playing a part in delivering the Scottish Land Fund, along with our colleagues in Big Lottery Fund Scotland. These first four grants, each for very different projects, will empower these community groups and help them to determine their own futures. This announcement is only the beginning of the journey for these groups and for the Land Fund itself."

The programme is funded by the Scottish Government and delivered in partnership by the Big Lottery Fund and Highlands and Islands enterprise, both of which have extensive experience of helping communities to acquire and develop their assets for over a decade.
